**Debtors** - Cashier's check or money order

<u>Debtors in Possession</u> - Business check imprinted with DIP, cashier's check, or money order

<u>Attorneys</u> - Attorneys are required to settle charges through Pay.Gov using a debit/credit card. In the occasional instance when an attorney is unable to use a debit/credit card, we will accept a check drawn on the attorney's trust account.

Non-Debtors - Credit/debit card, cashier's check, or money order
