REQUESTS FOR USE OF FRANK M. JOHNSON BUILDING ANNEX BANKRUPTCY COURTROOMS 4E AND 4F

In order to assist other Federal agencies with space issues and in order to better allow private entities the opportunity to further their active bankruptcy cases, the Bankruptcy Court for the Middle District of Alabama will allow outside use of the Frank M. Johnson Building Annex bankruptcy courtrooms 4E and 4F in certain situations.

ORDERED that the Bankruptcy Clerk of Court will only approve requests from Federal agencies and private entities to use the Frank M. Johnson Building Annex bankruptcy courtrooms 4E and 4F under the following conditions.

- a. Federal agencies will only be allowed to use the Frank M. Johnson Building Annex bankruptcy courtrooms 4E and 4F if the following criteria are met:
 - i. one of the two courtrooms is available;
 - ii. the attached Memorandum of Understanding is completed and signed by the requester; and
 - iii. the courtroom will only be used between the hours of 8:00 am and 5:00 pm on weekdays (not to include any Federal holidays).
- b. Private entities will only be allowed to use the Frank M. Johnson Building Annex bankruptcy courtrooms 4E and 4F if the following criteria are met:
 - i. the requester will only use the room for business concerning an active bankruptcy case in the Middle District of Alabama;
 - ii. one of the two courtrooms is available;
 - iii. the attached Memorandum of Understanding is completed and signed by the requester; and
 - iv. the courtroom will only be used between the hours of 8:00 am and 5:00 pm on weekdays (not to include any Federal holidays).
